WASHINGTON STATE WOMEN'S COMMISSION

FIRST 5 YEARS 2018-2023

Through a global pandemic and with an initial staff of two, WSWC worked to establish itself as the state's lead agency representing **3.8 million Washington women.**

After a period of *listening* in its first five years, WSWC is embarking on a new chapter to *deliver action* on gender pay equity & women's access to government services.

2023

- Convened 15 community organizations to establish the Women's Legislative Council during the 2023 Session to coordinate legislation affecting women.
- Developed a civic engagement social media campaign to inform the public on the legislative process, share bills tracked by WSWC, and encourage public engagement with legislators.
- Tracked <u>90 bills</u> during the 2023 Session, and advocated on behalf of 85 of those bills.
 - 35 bills signed into law by Governor Inslee
- Co-hosted the Women at the Capitol event that connected 150 women and girls with officials.
- Traveled to 8 cities and held <u>8 listening sessions.</u>
- Partnered with the U.S. State Department's Office of Global Women's Issues on the Asia-Pacific Economic Cooperation (APEC) Women in the Economy Forum:
 - Facebook Live event on "AI's Impact on Women: Understanding Occupational Segregation"
- With the Governor's Office, hosted Japanese Governor Saito and the Tamba Women's Entrepreneur Network for a conversation on women's economic empowerment in celebration of the 60th Anniversary of the Sister-State Relationship.
- Received the President's Award by the Washington Women Lawyers for advocacy work on reproductive access and privacy.
- Partnered with the Washington State Patrol (WSP) on an online survey to recruit more women to law enforcement roles in support of the 30 x 30 initiative.
- Sponsored the work of YWCA Spokane, El Centro de la Raza, and the Center for Women & Democracy to expand services for women of color.
- Co-hosted listening session with LGBTQ Commission.
- Hosted 2 "Office Hours On the Road" to hear from community members in their neighborhoods.
- Activated agency's first Strategic Plan (2023 2024).

2022


- Launched Young Women's Listening Tour with sessions in Tacoma, Seattle, Vancouver, and Spokane, in addition to one virtual event.
- Hosted webinar on the COVID-19 pandemic's toll on Latina/e women in Washington State.
- Facilitated a focus group of civilian and commissioned women WSP employees to discuss 30 x 30 initiative.
- Panel conversation on black women's mental health.
- Tracked 47 bills in the 2022 Session and advocated on behalf of 11 of those bills.
